#### AGREEMENT: Applicant understands and agrees to abide by ALL of the following terms:

- Application contains contractual terms which are binding, and not merely recital, and it has been filled out and signed of Applicant's free will.
- Cleared payment (check, cash, money-order) in total and in full for all fees is due to Bourse Chairman THIRTY DAYS IN ADVANCE of Show.
- All tables that comprise a "booth" are folding 6 ft. by 2 ft. tables. Chairs are common, plastic folding chairs. Electrical power is provided per booth.
- Dealer is not assured of participation in the coin show until explicitly stated by the Bourse Chairman, and your location may change from year to year.
- Physical location of booths on the bourse floor is at sole discretion of the Bourse Chairman, with preferred locations given to past participants.
- Some booth(s) may be configured as "corner booths" (no additional cost) at sole discretion of the Bourse Chairman, but expect a straight-line booth.
- Unless you specify otherwise, your company name/website as shown above may be listed in advertisements for the coin show without prior notice.
- Booth is occupied solely by Applicant and/or his agent(s), generally at all times, and shall not be subleased.
- ONLY Applicant or Applicant's agent(s) may act on Applicant's behalf at the Coin Show.
- Dealer shall collect and be responsible for all local and sales tax in accordance with current Florida State Law.
- Firearms and weapons are NOT permitted for use, nor for display nor for sale on the bourse floor.
- Items offered for sale or trade must generally be of numismatic nature, i.e. coins, paper money, bullion, exonomia, books, supplies and coin holders.
- Agreement can be cancelled up to 10 days prior to earliest date of show for a 75% refund, FORFEITING 25% OF FEES TO THE BOURSE CHAIRMAN.

#### THE APPLICANT:

- ... is at least eighteen years of age and competent to agree to and sign for all statements within this Application
- ... has legal title to and is owner of, or is legally the consignee of all merchandise for sale at the Applicant's table(s)
- ... understands that TNC provides NO INSURANCE against fire, theft, casualty, or any other loss of property
- ... shall be solely and legally responsible for collecting and paying all required state and local taxes
- ... shall be solely responsible for obtaining any required licenses or other identification
- ... is entirely responsible for damages to property caused by the Applicant or Applicant's agent(s)
- ... understands that the bourse floor is a smoke-free facility, and vaping is also not allowed on premises

#### RELEASE AND INDEMNITY AGREEMENT
